I am a Director on Legacy Ag Credit, ACA's (Legacy) Board of Directors and I appreciate the opportunity to comment on the Farm Credit Administration's (FCA) Proposed Rule regarding Collateral Evaluation Requirements that was published in the May 20, 2021 *Federal Register* (Proposed Rule).

As a Farm Credit System director, I am writing to express my concern that the Proposed Rule on collateral evaluation will have a negative impact on the agricultural producers, agribusinesses, and other customers we serve. The Proposed Rule would slow the loan-making process and place needless cost and burden on producers without any real benefit to the safety and soundness of Farm Credit System institutions. I respectfully ask FCA to withdraw the rule and engage Farm Credit System representatives in a constructive dialog designed to identify an approach to collateral evaluation requirements that is farmer friendly, recognizes modern practices, and simplifies the credit delivery process.
